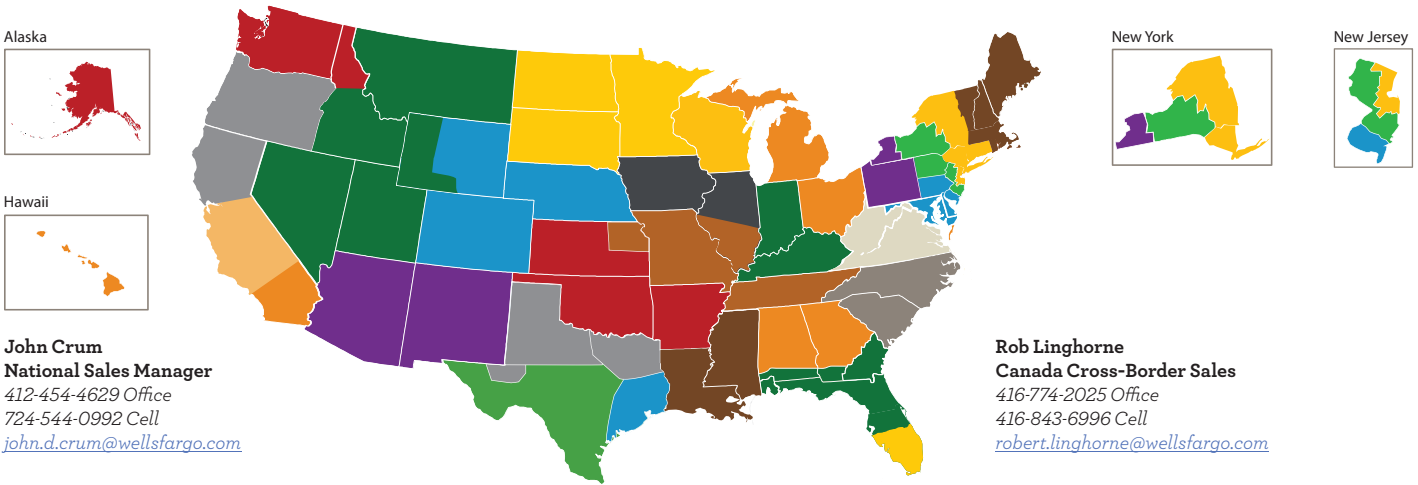




Construction Group coverage map
